- Cash Management Dropped
- State Authorization Dropped
- Accreditation Dropped
- TRIO Programs Dropped
- Return to Title IV (R2T4) DE Attendance Taking Dropped
- Distance Education

#### **NEW FEDERAL RULES**



### Final Regulations - Program Integrity & Institutional Quality Regulatory Package

Released 1/03/25; Effective 7/1/26; Reporting due 7/1/27

#### **Distance Education**

- Distance Education Course Definition
  - A distance education course includes non-instructional in-person activities.
  - Aligns with IPEDS definition.
- Distance Education Enrollment Reporting
  - Report student enrollment in distance education courses.
    - Procedure to be determined by ED.
    - This will be incorporated into the existing enrollment process in NSLDS.
    - First reporting deadline is 7/1/27.





- TPS was originally listed in the Notice of Intent to Establish a Rulemaking for the 2023-2024 rulemaking.
- ED intended to put in regulation rules as referenced in the 2023 Third Party Servicer Guidance and Request for Information addressing the 2011 Bundled Services Exception Guidance for OPMs.
  - Formal recission of the 2023 Guidance by November 18, 2024.
- Discussions before the election included the possibility of a revision to the 2011 Bundled Services Exception Guidance.
- Ultimately January 16, 2025, (GEN-25-01) Notice of interpretation regarding misrepresentations by third-party service providers engaged by an institution of higher education.

# January 16, 2025, Third-Party Servicer Interpretation

- Three types of misrepresentation are highlights
  - Inaccurately identifying an external servicer provider employee as an institutional employee
  - Inaccurately presenting a sales representative/recruiter as an academic advisor or counselor
  - "Describing a program, or any of its components or resources, provided in substantial part by the external service provider as 'the same as' a corollary residential or campus-based version of the program provided by the eligible institution."
- "Programs may not be equivalent if they have meaningful differences in rates of completion, job
  placement, earnings, or licensure.... For example, eligible institutions should be clear if the degree is
  awarded by an online division or campus of the institution that does or does not certify completion
  of the same curriculum taught by the same faculty as the campus-based degree."






Take away – The rules are the rules until they are no longer the rules!

<u>Loper Bright Enterprises & Raimondo and Relentless Inc. v. Department of</u>
Commerce

• Overturned the <u>Chevron Doctrine</u> - agency interpretation deference to determine statutory authority if the Federal statute is ambiguous or silent.

### Corner Post, Inc. v Board of Governors of the Federal Reserve System

• Directs that the 6-year statute of limitations for a legal challenge against the U.S. begins when the party (the plaintiff) is injured not when the regulation became final.

### Interstate Distance Education Regulations



- •34 CFR 600.9(c)

Federal Regulations tie compliance to participation in Title IV HEA programs.

### Effective since 7/1/20

- State Authorization
- Professional Licensure Disclosures
- Definition of state authorization reciprocity agreement


### Effective 7/1/24

- Program Participation Agreement Certification
  - Satisfy state educational requirements for a professional license.

### Federal Regulation for State Authorization

Of Distance Education (34 CFR 600.9(c)) effective July 1, 2020

- •Tied to Aid—Eligibility to disburse Title IV aid tied to the institution having approvals demonstrated by:
  - Direct approval by the state; or
  - •Through a state authorization reciprocity agreement.



#### Student Location

- •Defensible Process Document & to be provided to the Secretary upon request
- Determine at enrollment; or
- •Formal receipt of information from the student that the location has changed based on processes at the institution.

### Federal Regulation for Professional Licensure Disclosures

Disclosures (34 CFR 668.43(a)(5)(v) and (c)) effective July 1, 2020 \*public disclosures amended 2024



- 1.Regulations address all modalities (includes Face to Face and Online)
- 2.Educational Programs designed or advertised as leading to a license required for employment in the occupation.
- 3. Public notifications meets, does not meet, (states & territories where institution advertises or serves students).
- 4.Direct/individualized notification for prospective or enrolled students.

### New PPA Certification Requirements

Program Participation Agreement (PPA)

34 CFR 668.14(b)(32)

Raises the Bar When Offering Programs Leading to a License

For the program to be eligible for Title IV – the institution must satisfy state educational requirements

- Where the institution is located.
- Where the student enrolled in distance education
  - On or after July 1, 2024.
  - Is located at the initial time of enrollment.

OR

Where the student attests that they intend to seek employment




