The past year was an unquestionably historic one for the State University of New York with a new Chancellor and renewed and continuing funding support from the Governor and legislature. As SUNY continues to adjust to the post-Covid landscape of higher education, most campuses returned to a mix of face to face and online instruction, though remote options remained exceptionally popular. SUNY Online supported campuses across the system with their various forms of online instruction and continued to play an important role in supporting students and faculty during an unprecedented time. Throughout the year, SUNY faculty, staff, and students demonstrated resilience, adaptability, and determination. SUNY Online is proud to

provide resources and services in support of campus online initiatives.

Campuses are increasingly taking a strategic view of online education and understanding it to be a vital part of their overall enrollment and student success strategies. SUNY Online has been able to respond to this interest by establishing models and elevating best practices in the areas of online student supports, faculty support, and campus supports. SUNY Online has worked extensively with campuses to expand Communities of Practice, update models such as OSCQR and the Institutional Readiness process, and provide direct support to tens of thousands of faculty and students through the SUNY Online Help Desk. New services have been launched as part of the annual SUNY Online Service Level Agreement, and existing services modified and updated to best meet the needs of campuses.

Throughout 2023, a tremendous amount of time, energy, and attention from campuses, System Administration, and SUNY Online was paid to the implementation of the new Digital Learning Environment (DLE), including the D2L Brightspace learning management system. The full implementation of the DLE has the potential to transform the way that SUNY supports teaching and learning. The DLE provides each campus with access to a comprehensive digital learning environment that is robust, modern, reliable, secure, accessible, and easy to use for faculty, staff, and students. The DLE supports all modes of instruction, including online, face-to-face, synchronous, asynchronous, hybrid, and hyflex. The design of the DLE intentionally aligns with a set of SUNY level policies and standards for information security, identity management, authentication, accessibility, universal design for learning, online instructional design, assessment, and open education resources. By the end of 2023, all SUNY campuses were offering courses in the DLE. Hundreds of hours of training have been completed, dozens of tools have been integrated, and thousands of faculty and students are already teaching and learning in the new system. There is more work to be done, but the accomplishments are already impressive.

It is with great pride and a sense of deep appreciation that I am able to share this Impact Report with our partners, stakeholders, and members of the online education community. On behalf of the SUNY Online team, we are excited about the future and look forward to continuing this important work!



Established in 2014, the SUNY Online+ designation recognizes degrees and certificates across the system that exemplify the best of what SUNY has to offer in online education. The SUNY Online+ Signature Elements represent the shared commitment to the highest standards of quality and excellence in all facets of online education programming, student opportunity and success. Starting with 9 programs on 7 campuses, as of fall 2023 the SUNY Online+ program has grown to 143 programs on 26 campuses.

Since online education has quickly evolved since the last revision in 2018, this past spring, a team of SUNY Online+ campus partners and SUNY Online representatives thoroughly reviewed the elements and recommended changes. The following are the revised SUNY Online+ Signature Elements:

### **Student Support**

Online student support begins at the point of inquiry and continues seamlessly through admission, enrollment, persistence, program completion, and alumni status.



The EPR is a comprehensive discussion with campuses to develop a strategic plan for online programs, courses and supports that fit into their overall mission and vision of the campus. 22 SUNY campuses have engaged in the SUNY Online Enrollment Planning Roundtable (EPR) since its inception.

#### **SUNY ONLINE +**

SUNY Online+ programs exemplify the best of what SUNY has to offer in online education. With more than 900 online programs offered across 55 SUNY campuses, 143 campus programs are currently SUNY Online+ certified, from 26 SUNY campuses.

### **CAMPUS COMMUNICATION FORUM**

Viva Engage is now an official Microsoft application and available for desktop and mobile, and through your favorite internet browser. Viva Engage is available to all SUNY campuses and a shared instance is where SUNY Online hosts and manages many Communities of Practice (CoP) such as the new Online Student Success Collaborative, the SUNY Faculty Development, and the SUNY Online Teaching communities.

#### SUNY ONLINE DASHBOARDS

SUNY Online shares online learning data with campuses through a series of interactive data visualizations. To view the dashboards, you will need to log in to the website using SUNY federation.

### **UNIVERSITY-WIDE AGREEMENTS**

SUNY Online has established pricing agreements with several different vendors for proctoring services, captioning and accessibility services, and more.

### **HELP DESK SERVICES**

There are currently 44 campuses who utilize the SUNY Online Help Desk for Brightspace LMS Support. For a fraction of the cost of one FTE, participating campuses can receive up to 104 hours of support coverage for students, faculty, and campus staff. The SUNY Online Help Desk is open seven days a week and

includes coverage on most state holidays. The SUNY Online Help Desk also supports all 64 campuses with their Open Education Resources (OER) initiatives as well as the Student Conduct Institute (SCI).

For the 2022-2023 academic year the SUNY Online Help Desk provided direct support via phone calls, emails, or through the incident support portal for faculty, students, and staff.

### **APPLICATION SERVICES**

SUNY Online Application Services is supporting all SUNY campuses that have the ability to use the Digital Learning Environment (DLE). In addition they are supporting several organizations within SUNY such

as the Student Conduct Institute and the Educational Opportunity Centers in the DLE

The SUNY Digital Learning Environment Request for Proposal (RFP) was issued by the State University of New York on July 23, 2020. Since that time four cohorts of campuses are transitioning from implementation to operational mode, with all campuses expected to by using the DLE by the end of the spring 2024 semester.

### > THE DIGITAL LEARNING ENVIRONMENT (DLE)

Implementation has progressed on schedule with cohort 1 (comprised of 30 campuses) and cohort 2 (comprised of 8 campuses) implementations having been completed. The 11 cohort 3 campuses are in the final phase of implementation, and 7 cohort 4 campuses have entered the final phase on time for implementation completion for all cohort campuses by the end of 2023. In addition to the 54 SUNY campuses in the DLE shared instance there are also 3 SUNY institutions and an internal organization in Brightspace environment.

• The 2023 SUNY Online Summit was held March 8-10 as a hybrid event, both virtual and in

person in Syracuse, NY. There were 608 registered attendees from 56 SUNY campuses and 296 non-SUNY institutions/organizations. 2023 Session recordings can be viewed online here.

Over the past year, we engaged with 5 SUNY campus to develop scopes, plans, and estimates for varied types of ID services ranging from ID mentoring to online course reviews. For example, we developed, coordinated, and implemented an online faculty virtual drop-in services for SUNY North Country and SUNY Purchase to assist and supplement or provide campus ID supports that included weekly focused group discussion sessions on topics to reinforce Brightspace skills and faculty preparation for Fall 2023 and Spring 2024.

Topics included: Gradebook and Rubrics in Brightspace; Creating Gradable Activities; Teach and Manage your course in Brightspace; Communication Interaction/Engagement in your Online Course/ Designing and Building Online Class Community; Effective Tech-enhanced Teaching Practices; Effective Online Discussions; Ensuring Regular and Substantive Interaction; Cool Tools to Fire Up Online Learner Engagement; What Faculty can do to Support Online Learner Success

From January 2023—December 2023, there were 9 sessions of the SUNY Online Teaching Monthly Webinar Series. On average, 48 people attended each session.

# A NATIONAL COLLABORATION TO SUPPORT ONLINE DEI FOR ALL

SUNY Online is co-leading a national collaborative effort to infuse inclusive teaching practices into online course quality rubrics, including OSCQR. Diversity, Equity, and Inclusion (DEI) experts, and online education and online faculty experts, and staff from 66 institutions including SUNY, and organizations from across the country, and 2 institutions from Canada and Brazil, are collaborating to review, write, and annotate a set of openly-licensed freely available DEI annotations associated with the current major online course quality rubrics.

SUNY participants in this project plan to incorporate the DEI annotated practices into the OSCQR rubric. The DEI inclusive online teaching practices will be aligned with OSCQR standards and categories and will serve as a resource to support the work of online IDs, faculty, and their institutions to meet the SUNY DEI strategic mission to become leaders and champions of equitable, diverse, and inclusive education. This next version of the DEI-informed OSCQR rubric is tentatively expected to be release in Fall 2023.

By building DEI awareness in our existing communities of online practitioners at campus, online instructional designer (ID), and online faculty levels, and by providing them with information and suggestions for practical DEI-informed online inclusive teaching

practices, we can ensure, support, and contribute to DEI efforts in online teaching and learning activities across the system.




